Due to the unpredictability of the number of team entries for each tournament a limit has been set. If there is a high demand of teams that want to play on certain tournament dates, RMR Office has the authority to increase the tournament upon their discretion.

Tournament teams will be seeded according to their ranking in the region \*Division I for men will consist of the 5 & Women's Division 1 will consist of 10 highest ranked teams, followed by Division 2 the next 10 highest ranked teams, and so on through Division 3 and Division 4. \*Note: Exceptions of a 9 team division may be made in order to fill out a pool of at least five teams in the lowest division. If fewer than 20 teams enter a tournament, division structure may change.
